New York, October 17, 2017 - Trinity Logistics USA Inc., and Etihad Airways have collaborated on operating a 777F freighter between **Vietnam's Hanoi International Airport (HAN) and Ohio's Rickenbacker International Airport (LCK)**. The move represents the first time the airports have been directly connected, making the transfer of goods between the two countries faster than ever before.

The companies made history in 2016, by becoming the first and only alliance to operate a twice-weekly direct freighter service between Colombo, Sri Lanka and Rickenbacker International. A year later, their latest service promises clients three weekly flights from Asia to the East Coast of the United States, with Columbus, OH being the first port of entry.
