Today, the extension of its state-of-the-art logistics centre in Geel was inaugurated by the Honorary Chairman of Kuehne + Nagel International AG, Klaus-Michael Kuehne. Kuehne + Nagel's highly functional logistics centre in Geel has been taken into operation in 2006 and serves its key customers as import, storage and European distribution hub.
